Summary

 Following a period of monitoring the portfolio management team change in Q2 2024, Manulife Global Manager Research (GMR) upgraded Manulife Russell Investments Balanced Growth Fund, Manulife Russell Investments Multi-Asset Income Strategy Fund, and Manulife Russell Investments Long-Term Growth Fund (collectively, the Funds). The Funds are currently rated as In Good Standing.

Commentary

Senior Director and Head of Investments for Canada, Greg Nott, left Russell Investments Canada Limited (the Firm) on April 19th, 2024, to pursue another opportunity. As the Portfolio Manager (PM) of the Funds, Nott's responsibilities, which include day-to-day management and top-down asset allocation of the Funds, are distributed amongst the existing PMs within the Firm.

After a period of monitoring, GMR has concluded that the PM changes did not result in any process change, given the multi-manager nature of the Funds. The PMs continue to have the support of the broader Russell Manager Research team and Strategic Asset Allocation team. Performance of the Funds have remained in line with their respective strategic benchmarks and target returns.

GMR has determined that the concerns regarding the Funds have been resolved and has upgraded their status to In Good Standing.
