Drawing inspiration from its sustainably focused counterpart



Adhering to the same quality-driven approach targeting attractively valued companies with recurring tangible cash flows, Manulife Fundamental Global Equity Fund offers similar return potential. The difference is that this mandate operates without the sustainability overlay.

Go globally unconstrained with the fundamental difference

Manulife Fundamental Global Equity Fund is an unconstrained go-anywhere mandate with the flexibility to invest in distinct opportunities across the globe. It uses the same investment approach as Manulife Climate Action Fund but views investments through a more traditional lens. For those seeking an investment with greater flexibility and a few distinct differences, Manulife Fundamental Global Equity Fund serves as a close counterpart to the Climate Action Fund.

1st quartile ranking over all time periods


