This amendment to the SP of the Funds provides certain additional information relating to the Funds, and the SP, as amended, should be read subject to this information.

All page references relate to the SP. All capitalized terms not defined herein have the respective meanings set out in the SP. In all other respects, the disclosure in the SP is not revised.

**REASON FOR AMENDMENT:**

Manulife Investment Management Limited (“MIM Limited” or the “Manager”), the Manager of the Funds, announced a portfolio manager transition at Mawer Investment Management Ltd. (“Mawer”) impacting Manulife Global Equity Class, Manulife Global Equity Private Pool, Manulife Global Balanced Fund, and Manulife Global Balanced Private Trust. Christian Deckart, Portfolio Manager, Mawer is stepping down from his portfolio management duties but will remain with Mawer for a six-month transition period. As a result, Paul Moroz, Portfolio Manager, Mawer will return as lead manager for Manulife Global Equity Class

and Manulife Global Equity Private Pool together with David Ragan, Director and Portfolio Manager, Mawer who will assume co-manager duties, effective immediately. They will join Manar Hassan-Agha, Portfolio Manager, Mawer, who will continue his role as co-manager on the global equity strategies. Paul Moroz will also return as co-manager for the balanced strategies with the current team.

The technical amendments to the SP required to effect these amendments are set out below.

## **PURCHASERS' STATUTORY RIGHTS OF WITHDRAWAL AND RESCISSION**
