"Investment grade" simply means that these bonds are all rated BBB (low) or higher, implying that the risk that the issuer will default on paying its obligations is relatively low.

Within the category, however, there can be a lot of variation in yield, and that's where the strong credit skills of our team come into play.

We'll scour the investment-grade universe looking for pockets of opportunity, carefully assessing each potential investment and analyzing the strength of the issuing corporation. This helps us uncover incremental yield without stirring up incremental risk.
