AMENDMENT NO. 3 dated March 13, 2026 to the Simplified Prospectus dated August 1, 2025, as amended by Amendment No. 1 dated September 12, 2025 and Amendment No. 2 dated February 6, 2026 (the “SP”) of:

Manulife U.S. Opportunities Fund
Manulife Global Core Balanced Fund
Manulife Corporate Bond Fund
Manulife Corporate Fixed Income Private Trust

(each a “**Fund**” and, collectively, the “**Funds**”)

This amendment to the SP of the Fund provides certain additional information relating to the Fund, and the SP, as amended, should be read subject to this information.

All capitalized terms not defined herein have the respective meanings set out in the SP. In all other respects, the disclosure in the SP is not revised.

Manulife Investment Management Limited has announced its intention to lower the management fees of the Advisor Series, Series C, Series CT, Series F, Series FT and Series T securities of the Funds, as applicable, effective March 11, 2026.

The technical amendments to the SP required to effect these amendments are set out below.

Name, Formation and History of the Funds

Under the heading “Name, Formation and History of the Fund – Manulife Funds” under the sub-heading “Equity Funds – U.S. Equity Funds” in the column of the table titled “Changes”, the following is added for Manulife U.S. Opportunities Fund:

PURCHASERS' STATUTORY RIGHTS OF WITHDRAWAL AND RESCISSION

Mutual Fund Securities

Securities legislation in some provinces and territories gives you the right to withdraw from an agreement to buy mutual funds within two business days of receiving the Simplified Prospectus or Fund Facts, or to cancel your purchase within 48 hours of receiving confirmation of your order.

Securities legislation in some provinces and territories also allows you to cancel an agreement to buy mutual fund units and get your money back, or to make a claim for damages, if the Simplified Prospectus, Fund Facts or financial statements misrepresent any facts about the fund. These rights must usually be exercised within certain time limits.
